## **I. Call to Order**

## **III. Discussion on Newspaper Articles**

Two Collegian newspaper articles about UFFAB were published Wednesday October 3, 2012. Several Board members were contacted and asked questions about UFFAB and were uncertain how to respond. The Chair and Advisors decided the following.

For questions regarding the stadium:

\*UFFAB has nothing to do with the funding of the proposed on-campus stadium.

When talking with an interviewer/news reporter –

The Board also noticed a few corrections that should be made by the Collegian regarding the article titled, *\$61.2 million students fees pay for construction*. The first correction is the statement “UFFAB meets once a semester to review proposals for new projects.” The second correction The Board would like to make is “Fall 2012 proposals will be reviewed Oct. 4.” The third correction is the statement, “...nine of which are students.” The Board suggested that the Collegian be contacted and informed of the corrections.

## **IV. Tour of Occupational Therapy Renovation – 5:10 – 5:25pm**

The tour of the OT building allowed The Board to see where their money went and how the building was improved. Wendy Wood, OT department head, thanked the Board and is extremely happy with the renovation. She informed the Board that there is an overall better feel to the building and it is a healthier place now for students,

staff, and clients. Since the renovations, the lighting is better in the building, the floors are now safe due to the new carpet, and there is more student space, conference space, and research space. But most importantly, the clients, who are mostly CSU student veterans, are able to receive the care they deserve. Wendy also talked very highly of the project team and was very happy with everything they did. The total amount UFFAB donated to the renovation in OT was \$266,025.



Jesse Parker of Engineering gave the tour and stated that the room is almost always full of different Engineering students. Engineering representative Alex Brown stated that students seem to really enjoy the new area and use it a lot.

The next tour was of the MIL lab. The MIL lab project is set for two phases and the Board granted \$186,514 after two separate proposals. The most important upgrade to the MIL lab was removing a wall and allowing more space to meet safety standards.
