1. Renovation of SOCR Graduate Student Office – Courtland Kelly

- a. Remodel of office space in Soil and Crop Sciences department
 - i. Offices are for graduate students
- b. Current space has not been remodeled for at least 20 years
 - i. Carpet is very stained and difficult to clean
 - ii. Very few power sources and old desks make it difficult to work
- c. Benefit to students
 - i. Space is 100% student used, largely for graduate students
 - ii. Would provide a space for better mentoring and teaching
- d. Proposed upgrade to office
 - i. Increase space and desks in the office
 - ii. Create a cleaner and more organized space

- iii. Transition to laminate from carpet for easier cleaning
- iv. Some desks will be able to transition between sitting and standing
- e. Alignment with bylaws
 - i. Exclusively a student-used space
 - ii. Enhance productivity within this space by making it a nicer place to work
 - iii. Design will look more aesthetically appealing than the current space
 - iv. Design allows for more sustainable upkeep and long-lasting benefits
- f. Partial funding options
 - i. Go without paint job and purchase lower tier furniture
 - ii. Prioritize replacement of furniture
- g. Vote of Legitimacy in favor-12, opposed-0 Project is legitimized

2. Early Childhood Center (ECC) Exploratory Gardens and Mini Oval – Lise Youngblade and Karen Rattenborg

- a. UFFAB funded renovation of Washington School (built in 1919) for use by the ECC in 2013
- b. ECC is devoted to training students to teach children
- c. ECC has received donor help for the development of the outside of the ECC
- d. Use a teaching philosophy that highlights the environment, along with parents and teachers, as one of the main parts of a child's early education
 - i. Need to bring the environment up to par in order to best educate children
- e. Benefits to CSU students
 - i. Primary goal of ECC is to train students to become better teachers
 - ii. High demand for observation opportunities
 - iii. 132 CSU students at ECC in 2018
 - iv. Trains students for careers working with children in both education and occupational/music therapy
 - v. Hope to train students in using this teaching model that has an emphasis on the environment in the learning process
- f. Need for the project
 - Need to develop exterior spaces to enhance childhood education and CSU student learning
 - ii. Will also allow for better representation of the University by making this part of campus look better
- g. Project funding
 - i. Total goal of project is to raise \$190,000
 - ii. Requesting \$100,000 from UFFAB and will raise the remaining \$90,000
- h. Project design
 - i. Want to emulate the Oval at the ECC to make a good place for children to be a part of CSU traditions like Cans Around the Oval and Homecoming
 - ii. Inclusion of pollinator garden and picnic areas
- i. Vote of Legitimacy in favor-8, opposed-4 Project is legitimized
